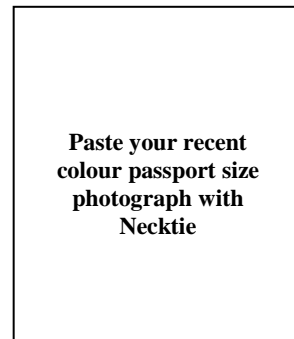

UNDERTAKING BY A STUDENT ON ADMISSION TO B.TECH COURSE

I, _____, on admission to I / II / III / IV Year of the B.Tech course, CS / EC / ME / CE Branch, hereby undertake to observe complete discipline as enforced by the college by its regulations in force at present and as notified from time to time. I also undertake that:

General

Rules & Regulations

(Academic, Sports & Extra-Curricular Activities)

1. I shall not absent myself from the theory classes and practicals except on account of serious illness. On joining after illness, I shall submit the following documents
 - i) Prescription by the doctor in original

 - iii) Doctor's illness and fitness certificates.
2. I shall not avail myself of any leave except for medical reasons.
3. I am fully aware that long absence on medical grounds shall indicate that I am not fit for pursuing studies and serious consequences may follow.
4. I shall not join any move to bunk /mass bunk classes. I know that if I do so, I shall be liable to pay a fine of Rs. 500 for each such instance.
